# Regular Meeting Minutes Of October 11, 2016 The Governing Board, Apache Elementary School

The October 11, 2016 Regular Board Meeting was held at Apache Elementary School at 5:30 pm. Representing the school district was Head Teacher-Palma Hudson and Business Manager-Tamara Winkler.

### I. PRELIMINARY MATTERS

- A. Call to order: Bill Kimble called the October 11, 2016 Regular Board Meeting to order at 5:30 pm.
- **B.** Pledge of Allegiance: Bill Kimble led the Board Members in the Pledge of Allegiance.
- C. Roll call: Present were Bill Kimble-Board President, Frank Krentz-Member and Michael Wood, Member
- **D. Agenda Adoption**: Mr. Krentz made a motion to approve the agenda as presented. This motion was seconded by Mr. Wood, a vote was held and the motion passed.

# A. Reports:

- Head Teacher Report: Mrs. Hudson reported on a past field trip to Animas Public School for picture day. The class stopped at the Rodeo Fire Department for a tour and bought lunch at the Rodeo Grocery and then went to Portal for a picnic. On October 17 they will take a field trip to Arevalos Farms Pumpkin Patch. She discussed getting a gasoline additive to keep the fuel from going bad. Mr. Krentz volunteered to put it in the tank. Mrs. Hudson discussed the correspondence problems with Mr. Wood's e-mail. She informed the Board that packets were available for pick-up the week before. She Reminded them they could call the school, e-mail her, come by the school or go the District website for the agenda and minutes.
- Enrollment Report: Apache Elementary School currently has 3 students enrolled.
- Business Office Report Mrs. Winkler reported on September expenditures by Fund and
  revenues received in September. She reported that District budget balances are where they
  should be for this time of year and there are currently no shortfalls in budget but there is a
  negative cash balance in the Maintenance and Operations fund as is normal for this time of
  year. At the beginning of the fiscal year in June there are several large, one time
  expenditures which result in a negative cash balance for that fund, but normally this
  situation is rectified as soon as property taxes are posted to the District.
