Pursuant to A.R.S. 38.431.02, notice is hereby given to the members of the Apache Elementary School District community that the Apache School District Board of Education will hold a meeting open to the public on the second Wednesday of each month beginning at 5:00 pm at the Apache Elementary School. To accommodate board members and staff, date and time of regular board meetings may be changed and will be announced in the posting of that meeting's agenda in advance. Pursuant to A.R.S. 38-431.03, the board may vote to move into executive session at any time to consult with the board attorney in person or via telephonic conference call on any matters listed on the agenda. (Executive session is not open to the public.)

Personal attacks upon Board Members, staff personnel, or other persons in attendance or absent by individuals who address the Board are discouraged. Presenters are cautioned that statements or representations concerning others that convey an unjustly unfavorable impression may subject the presenter to civil action for defamation. Policies KE, KEB, KEC, and KED are provided by the Board for disposition of legitimate complaints, including those involving individuals. "Call to the Public" is not an open discussion with the Board and Head Teacher.

Attachment of amended policy **BEDB © AGENDA**

The agenda shall list the specific matters to be discussed, considered or decided at the meeting. The Governing Board may discuss, consider or make decisions only on matters listed on the agenda and other matters related thereto. (Subject to A.R.S. 38-431.02)

Unless changed by a majority vote of Board members present at a meeting, the order of business shall be as follows:

Regular Meetings:

- Call to order
- Pledge of Allegiance
- Roll Call
- Adoption of agenda (discussion of items do not have to be in order)
- Approval of previous meeting minutes
- Approval of Consent Agenda
- Public Comments (Governing Board members shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action)
- Reports
 - Head Teacher
 - Business Manager
 - Governing Board Members
- Discussion / Action Items (Matters on which the Governing Board may take legal action during the meeting)
- Requests for future agenda items
- Adjournment

Special Meetings:

- ✓ *Call to Order*
- ✓ *Items for which the special meeting was called (may include timely action, discussion, and information items)*
- ✓ *Announcements*
- ✓ *Adjournment*

Executive Sessions:

- *An executive session may be scheduled, as necessary, during either a regular or special meeting (See Arizona Attorney General Agency Handbook Section 7.6.7)*
- *When an executive session is to be held, the notice must state the specific provision of law authorizing the executive session.*
- *The Board may vote to hold an executive session for the purpose of obtaining legal advice from the Board's attorney on any matter listed on the agenda pursuant to A.R.S. 38-431.03 (A)(3).*

Emergency Meetings:

In case of an actual emergency, the Governing Board, after giving such notice as is appropriate to the circumstances, may act on an emergency matter or call an emergency meeting in accordance with the requirements set out in A.R.S. 38-431.02. The emergency meeting shall follow the order of business for a special meeting. An emergency meeting shall be subsequently followed by the posting of a public notice within twenty-four (24) hours declaring that an emergency session has been held and setting forth the information specified by 38-431.02. Chapter 7 of the Arizona Agency Handbook shall be consulted for guidance when an emergency action or meeting is being considered.

Amended policy **GCCH ©**

PROFESSIONAL / SUPPORT STAFF BEREAVEMENT LEAVE

An employee may be granted, upon request to the Head Teacher, up to five (5) days of leave per event with pay, to be used in the event of death of the employee's family member as defined in Policy GCCA. Extensions of bereavement leave may be granted upon personal request to the Head Teacher. If approved, all such extensions of bereavement leave shall be deducted from the employee's accrued sick leave. In the absence of any accumulated sick leave, and upon request, the Head Teacher may approve an unpaid leave of absence for each day of extended bereavement leave used.
