**Minutes of the Apache Elementary School Board, December 8, 2020,
5:30 pm, conducted through Zoom on-line meeting site**

The Apache Elementary School Board met in its regular meeting December 8, 2020, 5:30 pm, and was conducted through the Zoom on-line meeting site. The meeting was held electronically due to the COVID-19 virus pandemic. Attending at the Apache School were Board Members, Dean Nelson and Mike Wolf, and Head Teacher, Loy Guzman. Attending on-line were Board Member, Maurine Joens, and Business Manager, Tamara Winkler. Mr. Nelson stated that if anyone was attending on-line and had a question or comment, to send it to the website for the Public Comment section of the meeting.

I. Preliminary Matters

- a)** Mr. Nelson called the meeting to order at 5:30 pm.
- b)** Mr. Nelson moved to adopt the agenda of the December 8, 2020, board meeting. Motion seconded by Mr. Wolf and carried unanimously.
- c)** Mr. Nelson led the group in the Pledge of Allegiance to the flag of the United States of America.
- d)** Mr. Nelson moved to approve the minutes of the November 10, 2020 board meeting. Motion seconded by Mrs. Joens and carried unanimously
- e)** Mr. Nelson moved to correct the minutes of the October 13, 2020, meeting correcting the statement that motion was made and carried to approve the minute of the October 13, 2020, meeting to read that motion was made and carried to approve the minutes of the September 8, 2020, meeting.

II. Reports

a) Head Teacher's Report

Ms. Guzman reported that the first semester was winding down and the students would get out of school for the holidays December 17 and have a celebration and gift exchange on December 15. There was a \$100 donation with another \$100 donation coming. Gov. Ducey and the Arizona Dept. of Health have mandated that for eighteen months anyone in the school building or on the bus must wear a mask. - b)** Mr. Nelson conducted the Board Self-evaluation. It was determined that none of the board members had noted any "need improvement" or "unsatisfactory" items on the Board Self-evaluation form.
