**Minutes of the Apache Elementary
School Board meeting April 14, 2026**

The Apache Elementary School Board met in its regular meeting April 14, 2026. Attending was board members Frank Krentz, and Stefanie Krentz. Head Teacher, Loy Guzman and Tamara Winkler, Business Manager was present at the school.

Preliminary Matter

- a) Mr. Krentz called the meeting to order at 5:30 pm.
- b) Mr. Krentz made the motion to approve board agenda April 14, 2026. Motion was seconded by Mrs. Krentz and carried unanimously.
- c) Mr. Krentz led the group in the Pledge of Allegiance to the flag of the United States of America.
- d) Mr. Krentz made the motion to approve the board minutes of Mach 17, 2026, Motion was seconded by Mrs. Krentz and carried unanimously.

II. Reports

a) Head Teacher's Report

Ms. Guzman stated that Smithsonian Star is going to pilot a program with our school. Scientists taking astronomy to rural schools. They will be here May 12th for a visit. Students have finished the Arizona state testing.

Specific Items of District Business

- a) Employee health insurance was discussed. Asbait health insurance was the lowest amount for \$11,937.60 out of 7 quotes. Mr. Krentz made the motion to go with Asbait health insurance starting July 1, 2026. Also in the motion, if the employee declines district funded health care, they will receive equal value in a health care stipend, District health care insurance will be reviewed each year. Mrs. Krentz seconded the motion and carried unanimously.
- b) Performance audit preliminary findings – Ms. Guzman and Mrs. Winkler told the board that they had a meeting with the AZ Auditor General office. No discussion took place.
- c) Mr. Krentz made the motion to approve the Cochise County Treasurer Continuing Resolution – authorizing the Cochise Treasurer of Cochise County, Arizona, to invest and reinvest all monies as authorized by law in accordance with A.R.S.15-1025. Mrs. Krentz seconded the motion and carried unanimously.
